A snapshot of the 2015 districtwide results in ELA and Math for grades 3-8 and 11 and Science for grades 5, 8 and 10 were presented. The Science assessment is still based on the CST, but will change in the future. Dr. Fuentes also shared that test scores are just one part of the larger picture for student learning.
