- Rachel Canchola, thanked Gisela Castañon, Birney Elementary School Principal, for hosting Board Meeting and for the student council presentation. She announced that El Rancho High School Baseball will be hosting their first Hall of Fame Dinner this Sunday, January 22, 2012 at 5 p.m. at the Pio PicoWomen's Club; she encouraged everyone to attend the event and support our student athletes. She spoke regarding a special meeting held last year regarding school safety. Doesn't know if another meeting will be called but she strongly encourages district to resolve all issues regarding school safety. She asked that the locker rooms be kept clean. Academic Decathlon is starting, encouraged all to support the team.
- Dr. Joseph Rivera read a letter from Dr. Coté, dated December 15, 2011, which states that for the 2012-2013 school year she will not accept her longevity stipend, effective July 1, 2012, instead the stipend amount is to be used in the district's general funds for the benefit of the children in Pico Rivera.
