PUBLIC HEARING:

The Board of Education will hold a public hearing regarding Tri-Cities Regional Occupational Program's submittal of a General Waiver Request to the California Department of Education to waive Education Code 52321, Regional Occupation Center or Program reserve limitation. This waiver allows Tri-Cities ROP to maintain a reserve greater than 15% for educational purposes through June 30, 2009. These increased funds are the result of Tri-Cities ROP's ability to access excess ADA, which was redistributed from 2005-2006 when Los Angeles Unified School District claimed nearly 4,000 fewer ADA than allowed under its cap.
